Dear Mr. Mobley,

The National Oceanic and Atmospheric Administration (NOAA) Channel Islands National Marine Sanctuary (CINMS or Sanctuary) Advisory Council is a 21-member body of community members and government agencies that advise the Sanctuary Manager and NOAA on management of the Sanctuary. At our March 14, 2008 Sanctuary Advisory Council (Council) meeting, the Council was alerted to the loss of buoy maintenance for two weather buoys in the Santa Barbara region.

Thank you for your previous support of maintenance and operation of NOAA weather buoys, including #46054, West Santa Barbara Channel, and #46023, Point Arguello.

The CINMS cherishes the rich maritime history of our area, both recreational and commercial, and we are writing to enlist your support in our effort to strongly urge continued operation and maintenance of weather buoys #46054, West Santa Barbara Channel, and #46023, Point Arguello, both scheduled for decommissioning after the end of 2008 or upon failure (http://www.wrh.noaa.gov/lox/buoy_removal.pdf).

Information from these buoys is critical to the safe transit of pleasure boats, commercial fishing vessels, merchant shipping, and oil tankers through the Santa Barbara Channel, and specifically the National Marine Sanctuary. The weather and sea conditions at the West SB Channel buoy are often very different than at the Pt Conception buoy, even though they are only 11 miles apart. The loss of these fundamental information tools would create a 'data blackout' in and around the west end









of the Santa Barbara Channel, creating a potential safety risk for the thousands of visitors and mariners that annually travel these waters.

Of particular concern is the risk of lost response time to an environmental hazard such as an oil spill or marine accident. This area of the channel is well known for turning from calm to convulsive in a very short time, and without current weather information clean-up or rescue response could be compromised.

Removal of these buoys will result in more time, money, and fuel spent by boaters as they 'explore' the channel's weather. Currently the information received from the buoys helps to limit the use of such resources, and plays a small part in keeping our waters clean.

In no small part, our area and the CINMS is tightly connected to ocean activities. Swimming, surfing, snorkeling, diving, and kayaking make up a significant part of California's culture. Thousands of individuals rely on accurate buoy data to help them decide where and when to enjoy their ocean activity. Without this valuable information, more resources will be spent both on land and sea to determine activity locations. This will result in more vehicle traffic along our roads and highways, leading to an increase in congestion and pollution.

Thank you for considering our comments, and we urge you to continue your support of maintenance and operation of buoys #46054, West Santa Barbara Channel, and #46023, Point Arguello.
