Biological & Socioeconomic Monitoring of Channel Islands MPAs	<ul> <li>a) Hear and learn from scientists that have been conducting monitoring in/around the Channel Islands MPAs</li> <li>b) Consistent with past reporting from the Research Activities Panel (RAP) hear an informal characterization of the status of key biological/ecological MPA monitoring programs/studies at the Channel Islands, based on scientists sharing status info.</li> </ul>	<ul> <li>a) Complete. In November 2015, Dr. Robert Warner summarized findings from a paper published in Scientific Reports: Recovery trajectories of kelp forest animals are rapid yet spatially variable across a network of temperate marine protected areas (Jennifer E. Caselle, Andrew Rassweiler, Scott L. Hamilton &amp; Robert R. Warner). In 2016, no new presentations provided to the SAC, but 4 talks were given in October at the California Islands Symposium that related to the study of effects of Channel Islands MPAs<sup>2</sup>.</li> <li>b) Partially complete. The RAP met in May, reviewing Channel Islands programs and projects. A report-out followed at a subsequent SAC mtg.</li> </ul>

Although the council did not receive a specific presentation on this topic, brief announcements about activities of the SB Channel MPA Collaborative continued to be provided to the SAC via Conservation Working Group reporting.</li> <li>b) Complete. A TAC report was provided in July, accompanied by a detailed presentation on the NOAA Office of Law Enforcement provided by Dayna Matthews. Also, a presentation on NOAA's office of General Counsel for Enforcement was provided in November.</li> </ul>	н

No presentations by Visit Santa Barbara or other tourism boards in 2016, although CINMS has been reaching out to them for marketing ideas and to assist with advisory council recruitment leads.</li> <li>d) Partially Complete. The council did not receive a special presentation on this or engage in discussion about it, but council members were notified by email about upcoming Webinar sessions.	٦

Youth Involvement	Sanctuary Education Team to help high schools pursue NOAA grant funding to help high school student groups engage in sanctuary-related projects, including consulting with and presenting to the advisory council. This was considered by the SET and investigated, but a specific project, with grant-funding and designed to interface with the SAC, did not come together in 2016. This could include learning from upcoming cruises (April/May 2016) on the NOAA R/V Bell M Shimada featuring ROV operations as well an Ocean Exploration Trust deep water mission aboard the E/V Nautilus in July 2016.</li> </ul>	<ul> <li>a) Incomplete. This did not happen in 2016.</li> <li>b) Partially complete. In July, Chis Caldow, Julie Bursek and Chris Mobley reported to the SAC on the study or deep sea areas within CINMS, including coral habitats, as part of the Nautilus Live expedition, and Caldow reported on other seafloor mapping expeditions that occurred in 2016.</li> </ul>	M

Climate Change Adaptation	<ul> <li>a) Consider convening a climate change panel to inform the council on the issue of adaptation.</li> <li>b) Learn about rapid vulnerability assessment tool for climate change impacts (connect with Greater Farallones National Marine Sanctuary). Recommend bringing in expertise on modeling of shoreline change.</li> </ul>	a) & b) Mostly complete. Although not set up as a panel, the council did receive a thorough explanation in September of how the Greater Farallones National Marine Sanctuary and partners assessed expected climate impacts to habitats and identified adaptation strategies. This included an explanation of a rapid vulnerability assessment approach, which CINMS and CINP recently began working on. In addition, in November the council heard from Dr. Claudia Anderson about Harmful Algal Blooms.	н

Presentation by and council discussion with the Navy (J. Ugoretz) in July. This was followed by sharing announcements with the SAC when the Navy's draft environmental document was available for review and comment.	L

The advisory council received two presentations from NOAA enforcement officials in 2016: Office of Law Enforcement (Dayna Matthews, July) and General Counsel Enforcement Section (Paul Ortiz, November). The council also learned about Chair Dianne Black's role in working with four other council Chairs/members from around the sanctuary system to craft a letter to NOAA leadership about the need for increasing attention to enforcement of sanctuary regulations, and in November approved of the Chair signing on to that letter.
